

## **Reward and Recognition Opportunity Drawing Official Rules**

1. **PARTICIPATION LEVELS:** Each online community activity earns participants 5 to 10 points depending on the length of the activity. The following levels are achieved based on points:
  - Designer Level = 50 Points
  - Advisor Level = 100 Points
  - Expert Level = 200 + Points
  
2. **ANNUAL OPPORTUNITY DRAWING:** All participants reaching the Expert level are entered into an opportunity drawing (“Opportunity Drawing”) that will occur in January of each year based on participation levels achieved in the prior year. Ten winners will be selected randomly to receive a code to redeem a \$100 HyperWallet gift card. This will be administered through a third party (Vision Critical). All decisions on matters pertaining to the Opportunity Drawing are final. Each winner is responsible for any and all taxes, fees, and/or costs related to the winner’s receipt of a prize. Limit one prize per person, family or household. Odds of winning depend on the number of eligible entries received. Winners may be ineligible to receive a prize if prohibited by applicable laws.
  
3. **ELIGIBILITY:** The Opportunity Drawing is sponsored by Sharp HealthCare, 8695 Spectrum Center Blvd. San Diego, CA 92123 (the “**Sponsor**”). Vision Critical Communications Inc. (the “**Administrator**”) has been retained by Sponsor to administer the Opportunity Drawing. Administrator is and shall remain solely responsible for the delivery of the prize(s) to the winner(s). Tracking of online community activities to determine eligibility for participation in each Opportunity Drawing shall begin at 12:00 a.m. Eastern Standard Time (“EST”) on January 1 of each year, and shall continue until 12:00 a.m. EST on January 1 of the following year (each, a “Drawing Term”). The first Drawing Term shall commence at 12:00 a.m. EST on January 1, 2016, and will terminate at 12:00 a.m. EST on January 1, 2017 (“First Drawing Term”). The first Opportunity Drawing will be held in January 2017 after expiration of the First Drawing Term, and subsequent Opportunity Drawings will continue to be held each January thereafter until Sponsor terminates this Opportunity Drawing in its sole discretion. The term and duration of the Opportunity Drawing may end at any time in the sole discretion of Sponsor; provided, however, that all prizes will be awarded for the period in which such termination occurs. This Opportunity Drawing is open to all Expert level participant members of Sharp Insight Community (“**Entrants**”) who have participated in a voluntary survey in the past year. All Entrants must be individuals legally residing in one of the 50 United States, at least 18 years of age and not a Sharp HealthCare employee (or employee’s family member) or a Sharp HealthCare physician (or his or her family member). **VOID WHERE PROHIBITED.**

4. **HOW TO ENTER:** The Opportunity Drawing is offered electronically via the Internet. Entrants are entered by achieving the Expert level of participation in the surveys. The participation is valid for that current year's drawing. If you achieve Expert level participation in the year prior to the drawing, you are eligible. The draw date will occur in January of each year. **NO PURCHASE OF ANY KIND IS NECESSARY TO ENTER OR WIN.**
5. **LIMIT:** One (1) entry per person. Subsequent entries will be disqualified. Sponsor is not responsible for lost, late, misdirected, or incomplete entries, or for any computer-related, online, telephonic, or technical malfunctions that may occur. In the event of a dispute regarding who submitted an entry, the entry will be deemed submitted by the authorized account holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by an Internet access provider, online service provider or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address. A selected Entrant may be required to provide Sponsor with proof that he/she is the authorized account holder of the email address associated with the selected entry.
6. **WINNER NOTIFICATION:** Random selection of the potential winners will occur on or about January 30<sup>th</sup> from among all eligible entries received for the applicable period. Prize drawing will be conducted by Administrator. The potential winners will be notified by email on or about the first Monday after the drawing. Potential winners will have thirty (30) days from notification to claim their prizes. Sponsor and Administrator and their affiliates, subsidiaries, directors, officers, employees, agents, and representatives will not be liable for unsuccessful efforts to notify a winner. Prizes will be delivered by first class mail. No prize transfer, assignment or substitution by winner is permitted. Sponsor may substitute the prize for one of equal or greater value. All federal, state and local taxes, fees and surcharges on prizes are the sole responsibility of the winners. Winners may be required to complete a release and provide tax identification or other information prior to receiving their prize. If any potential winner declines his or her prize, fails to claim the prize, is unavailable for prize fulfillment, fails to abide by the Official Rules, or is ineligible, Sponsor may select an alternate winner from all remaining eligible entries. If any prize or prize notification is returned as undeliverable, that prize is forfeited and Sponsor may select an alternate winner from all remaining eligible entries. You may be required to sign a confidentiality agreement prior to receiving the winners list.

## **7. LIMITATION OF LIABILITY:**

Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Opportunity Drawing.

Sponsor and Administrator shall not be responsible if the Opportunity Drawing cannot take place or if any prize cannot be awarded due to reasons outside of Sponsor's or Administrator's control including acts of war, natural disasters, weather or acts of terrorism. Entrants who do not comply with these Official Rules, or who attempt to interfere with the Opportunity Drawing in any way shall be disqualified.

By participating, Entrants and winners release Sponsor, Administrator, and their Sponsor and Administrator and their affiliates, subsidiaries, directors, officers, employees, agents, and representatives, as well as all others associated with the development and execution of this Opportunity Drawing, from and against any and all liability with respect to or in any way arising from the Opportunity Drawing and the awarding and use of the prizes. Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, or delay in operation or transmission; communications line failure; theft, destruction, alteration, or unauthorized access to Opportunity Drawing entries.

Participants, Entrants and Opportunity Drawing winners agree (a) to be bound by these Official Rules; and (b) that the decisions of Sponsor are final on all matters relating to the Opportunity Drawing.
